**DECLARATION OF DAVID C. RAPHAEL, JR. ON BEHALF OF
SMITH, SEGURA, RAPHAEL & LEGER IN SUPPORT OF CLASS COUNSEL'S
MOTION FOR ATTORNEYS' FEES, REIMBURSEMENT OF EXPENSES, AND
SERVICE AWARDS FOR THE NAMED PLAINTIFFS**

David C. Raphael, Jr., subject to the penalties of perjury provided by 18 U.S.C. § 1746, does hereby declare as follows:

1. I am a partner in the law firm Smith Segura Raphael & Leger, LLP, attorneys for the Direct Purchaser Class Plaintiffs and class representative Value Drug Company ("Value Drug"). I submit this declaration in support of Direct Purchaser Plaintiffs' Motion for Attorneys' Fees, Reimbursement of Expenses, and Service Awards for the Named Plaintiffs.

2. During the course of this litigation, my firm has been involved in various activities on behalf of the Direct Purchaser Class. Chief among those activities were:

- Investigating the case and helping to prepare initial complaints in this matter;
- Managing and coordinating discovery and document production by direct purchaser class representative Value Drug Company ("Value Drug"), including drafting responses to written discovery requests, negotiating with Defendants regarding the scope of discovery directed to Plaintiffs, collecting and reviewing Value Drug data and documents for production, and preparing for and defending depositions;
- Reviewing, analyzing, and digesting hundreds of thousands of pages of documents and data produced by Defendants, and participating in all aspects

of discovery, including taking and defending fact and expert depositions;

- Working with industry experts concerning all aspects of the case;
- Participating in drafting various briefs and related filings, including: the opposition to Defendants' motions for summary judgment; oppositions to *Daubert* motions; affirmative *Daubert* motions; affirmative motions *in limine*; oppositions to motions *in limine*; and various pretrial submissions;
- Preparing for and participating in trial, including preparation of plaintiff witnesses for trial testimony, trial examinations of fact and expert witnesses, editing of deposition testimony to be played by video, and negotiations and argument concerning same;
- Consulting with lead counsel and direct purchaser class representative, Value Drug Company, in connection with settlement discussions with Impax.

3. All attorneys, paralegals and staff at my firm were instructed to keep contemporaneous time records reflecting their time spent on this case and did so.

4. The schedule below reports the time spent by my firm's attorneys, paralegals, and staff in this case from inception until July 4, 2022 and time thereafter related to this settlement only. This does not include time relating to this motion and post-trial briefing.
